- Whereas* **Brother Reeves** was born November 30, 1932 and,
- Whereas* he exemplified the Fraternity's fundamental purpose of achievement in his chosen field of endeavor and throughout the fabric of his life; and,
- Whereas* **Brother Reeves** was the fraternity's 449 initiate in 1952 into the bond of Kappa Alpha Psi Fraternity, Inc. through Virginia State College now Virginia State University, the Alpha Phi Chapter of Kappa Alpha Psi, on April 26, 1952; and,

- Whereas* his life of service to Kappa Alpha Psi and to mankind is worthy of high praise, therefore,
